All community emails from NFMD come from the web site, so you must join the web site to get those e-mails. As always if you ever have questions; call or e-mail NFMD.

Some people ask what is Northfield Metro Districts and what does it do for me? It is a local governmental agency, collects taxes to pay for the infrastructure of the community, that the local Town or County could not afford to pay for.

In addition to the tax collected for the bond to pay for the infrastructure, NFMD does assessed a yearly Operations & Maintenance fee to the HOA's to maintain the integrity of the landscape, snow removal, irrigation, driveways, parking areas, detention ponds, drainage, open space, monuments, accounting, budgeting and financial reporting and long-term reserves, among some of the items or you can see the District budgets on the web site.

The District handles all the maintenance outside of the units, the HOA handles the actual buildings and the building envelopes maintenance, which is the Townhome and Condo building exteriors, the driveway to the garage, and the small, fenced area of each of the Townhomes.

<u>Trash/Recycle Removal Service at NFMD:</u> Republic Services is the approved vendor by the HOA: Republic Services can be reached at 970-484-5556 or https://www.republicservices.com/residents/solid-waste

The Condo's HOA set up trash pickup, <u>Townhome owners set up their own trash/recycle removal Service through Republic</u>.

The governing Board has <u>designated trash/recycle day on Thursday</u> to reduce noise, wear on the streets and to enhance the safety and cleanliness of the neighbors. (NFMD TRASH/RECYCLE DAY IS THURSDAY)

<u>Maintenance and snow removal:</u> If you see issues, please e-mail, or call the District for any outside maintenance issues, broken irrigation, issue with a dog station or snow removal, etc... with a picture if can, precise location of the issue is very helpful.

Snow removal around these building's and parking lot's is a challenge. Limited areas to move snow to and the shade of the buildings on the north facing units or driveways areas is a big challenge. Then snow melt and slush being splashed around, and drainage is slowed by lower temperatures. The District and contractor will do what they can while watching the budgets, but keep in mind areas maybe icy.

<u>Parking in NFMD</u>: No parking in fire lanes. See NFMD guidelines for information on vehicles. Note, parking limitations on commercial or larger vehicles, trailers, or any long-term parking. Also, some parking spaces may be used temporary snow storage after larger snowstorms.
